**Frequently Asked Questions**

**How do I watch the AGM live webcast and/or audio-only stream?**

You will need to take the following steps:

Step 1 : Go to the pre-registration website <https://online.meetings.vision/stamfordtyres-agm-registration>

Step 2 : Click on the "Register for AGM" button.

If you have made multiple registrations, we will take your last registration as your final registration.

Step 3 : Complete the information required on registration page and click "Preview".

Step 4 : Review your input and ensure it is accurate before clicking "Submit".

Step 5 : After you click "Submit", an acknowledgement of your registration will appear on the registration page, followed by an acknowledgement sent to your email address.

If you do not receive an email acknowledgement after your registration, it means your pre-registration is unsuccessful. Please check your spam/junk email folder or try again. Do ensure you have entered a valid email address.

Step 6(a): Following verification that you are a shareholder of Stamford Tyres Corporation Limited, an email will be sent to you by 28 September 2021, 12.00 noon with your login credentials and the link to access the audio-visual or audio-only stream.

Step 6(b): If we are unable to verify that you are a shareholder/proxy on our records, you will receive an email by 28 September 2021, 12.00 noon to notify you that we are unable to verify your shareholder status.

Step 7 : On the day of the AGM 29 September 2021, 3.00 p.m. you will need to log in to the audio-visual or dial in to the toll-free telephone number to listen to audio-only stream.

Shareholders who do not receive an email by 28 September 2021, 12.00 noon but have registered by the 26 September 2021, 3.00 p.m. deadline should email our Polling Agent, Trusted Services Pte. Ltd., at [opr@trustedservices.com.sg](mailto:opr@trustedservices.com.sg) for assistance.

### **When will I receive the login credentials?**

Authenticated shareholders will receive an email by 28 September 2021, 12.00 noon. The email will contain credentials to view the webcast and/or audio-only stream, as well as the link to access the webcast and/or audio-only stream to the AGM proceedings.

Shareholders who do not receive an email by 28 September 2021, 12.00 noon but have registered by the 26 September 2021, 3.00 p.m. deadline should email our Polling Agent, Trusted Services Pte. Ltd., at [opr@trustedservices.com.sg](mailto:opr@trustedservices.com.sg) for assistance.

### **What happens if Stamford Tyres Corporation Limited cannot verify my shareholder status?**

You will receive an email by 28 September 2021, 12.00 noon notifying you that we are unable to verify your shareholder status, and therefore, you will not be able to have login access to the webcast and/or audio-only stream of the AGM proceedings.

### **Who can register to watch the AGM via live webcast and/or audio-only stream?**

Only registered shareholders of Stamford Tyres Corporation Limited will be able to register to watch the webcast and/or listen to audio-only stream.

### **Can I register my representative to watch the webcast and/or audio-only stream?**

No. Only registered shareholders of Stamford Tyres Corporation Limited will be able to register to watch the webcast and/or listen to the audio-only stream.

### **If I hold Stamford Tyres Corporation Limited shares via a securities sub-account in a depository agent (e.g. a nominees' company), can I register to watch the webcast online and/or listen to the audio-only stream?**

We regret that you will not be able to register to watch the webcast and/or listen to the audio-only stream online.

You should contact the relevant intermediary through which you hold such shares as soon as possible in order to make the necessary arrangements for you to participate in the AGM.

### **What information do I need to provide to register online?**

You will need to provide the following information:

- Name (As per CDP/CPF/SRS records. If your shares are held under Joint Shareholders, please fill in both shareholders' names as per in the records. However, only one NRIC/Passport number and email address is required.)
- Email Address
- Shareholding type (How your Stamford Tyres Corporation Limited shares are held)
- NRIC or Passport Number
- Provide a valid mobile or landline number that will be used to dial in for the Audio Only stream.

### **Why do I need to provide my full NRIC number?**

This is to enable Stamford Tyres Corporation Limited to verify that you are a shareholder.

### **How to watch the Webcast**

#### **What do I need to watch the webcast?**

You will require an internet enabled device such as a computer, mobile phone or tablet to view the webcast. Ensure you are connected to Wi-Fi as viewing the webcast can consume a large amount of data.

#### **What are the supported browsers?**

You may watch the live webcast from any device as long as:

- Your browser is HTML5-compatible (e.g. Microsoft Edge, Chrome, Firefox)
- You have a stable WIFI connection or LAN connection
- You have a connection speed of at least 1.8mbps to watch the webcast in 480p or a connection speed of at least 2.5mbps to watch the webcast in 720p

You will need :

- minimum stable download speeds of 500 kbps or faster in order to view our lowest quality, SD 240p live stream.
- a dedicated Internet line of 5 Mbps or faster to stream and download high quality videos on the Internet

## ANNOUNCEMENT

### **ANNUAL GENERAL MEETING TO BE HELD ON 29 SEPTEMBER 2021 AT 3.00 P.M.**

1. **Background:** Stamford Tyres Corporation Limited (“**Stamford Tyres**” or the “**Company**”) refers to:
  - (a) the COVID-19 (Temporary Measures) Act 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, teleconferencing or other electronic means;
  - (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the “**Order**”) which sets out the alternative arrangements in respect of, *inter alia*, general meetings of companies;
  - (c) the joint statement by the Accounting and Corporate Regulatory Authority (“**ACRA**”), Monetary Authority of Singapore and Singapore Exchange Regulation (“**SGX RegCo**”) of 13 April 2020 (and subsequently updated on 27 April 2020, 22 June 2020 and 1 October 2020) which provides additional guidance on the conduct of general meetings amid the eveloving COVID-19 situation; and
  - (d) the Company’s announcement dated 30 June 2021 on the extension of time granted by ACRA and SGX RegCo for the Company to hold its Annual General Meeting (“**AGM**”).
2. **Date, time and conduct of AGM:** The Company is pleased to announce that pursuant to the Order, the AGM will be convened and held by way of electronic means on **Wednesday, 29 September 2021 at 3.00 p.m.** (Singapore time).
3. **Notice of AGM and Proxy Form:** The Notice of AGM and Proxy Form will be sent to shareholders solely by electronic means via publication on the Company’s corporate website and will also be made available on the SGX website<sup>1</sup>. Printed copies of these documents will not be sent to shareholders.
4. **No personal attendance at the AGM:** Due to the current COVID-19 situation in Singapore, **shareholders will not be able to attend the AGM in person.**
5. **Alternative arrangements for participation in the AGM:** Shareholders may participate in the AGM by:

- (a) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
- (b) submitting questions in advance of the AGM; and/or
- (c) appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM.

Details of the steps for pre-registration, pre-submission of questions and voting at the AGM by shareholders, including CPF and SRS investors, are set out in the Appendix to this announcement. In particular, CPF and SRS investors who wish to appoint the Chairman of the Meeting as proxy should approach their respective CPF Agent Banks or SRS Operators by **5.00 p.m. on 20 September 2021** to submit their votes.

6. **Persons who hold shares through relevant intermediaries:** Persons who hold Stamford Tyres shares through relevant intermediaries (as defined in section 181 of the Companies Act, Chapter 50), other than CPF and SRS investors, and who wish to participate in the AGM by:

- (a) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
- (b) submitting questions in advance of the AGM; and/or
- (c) appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM,

should contact the relevant intermediary through which they hold such shares as soon as possible in order for the necessary arrangements to be made for their participation in the AGM.

7. **Annual Report 2021:** The Company's Annual Report 2021 has been published on the Company's corporate website and may be accessed at <http://www.stamfordtyres.listedcompany.com/agm.html> by clicking on the hyperlink for "Annual Report 2021"; and will also be made available on the SGX website at <https://www.sgx.com/securities/company-announcements>.

8. **Record date and payment date for first and final dividend:** The Transfer Books and Register of Members of the Company will be closed on 8 October 2021 at 5.00 p.m. for the purpose of determining shareholders' entitlements to the proposed first and final tax exempt (one-tier) dividend of 1.25 cents per ordinary share for the financial year ended 30 April 2021 (the "**Proposed Dividend**").

Duly completed transfers received by the Company's Share Registrar, Boardroom Corporate & Advisory Services, at 50 Raffles Place, #32-01 Singapore Land Tower, Singapore 048623 up to 5.00 p.m. on 8 October 2021 (the "**Record Date**") will be registered before shareholders' entitlements to the Proposed Dividend are determined. Shareholders (being Depositors) whose securities accounts with The Central Depository (Pte) Limited are credited with shares as at 5.00 p.m. on the Record Date will rank for the Proposed Dividend. The Proposed Dividend, if approved at the AGM, will be paid on 20 October 2021.
